# About AAM Membership

## Membership Categories and Dues

**AAM:** Regular, Introductory or Associate

**Biosimilars Council:** Regular or Associate

Membership is available only to organizations. We do not offer individual memberships.

### AAM Regular Members

A corporation, partnership or other legal entity whose business in the United States consists of the development, commercialization, manufacture, sale and/or marketing of finished dose products with twenty-five percent (25%) or more of its net revenues, manufacturing volumes or pipeline investments relating to:

- (1) products described in Abbreviated New Drug Applications filed with and approved by the U.S. Food and Drug Administration (the "FDA") under section 505(j) of the Federal Food, Drug, and Cosmetic Act ("FDCA") (hereinafter, "ANDA Products");
- (2) generic products marketed pursuant to section 505(b)(2) of the FDCA (hereinafter "505(b)(2) Products");
- (3) biosimilar products, as defined in Section 351(k) of the Public Health Service Act (hereinafter "Biosimilar Products");
- (4) Drug Efficacy Study Implementation products (hereinafter "DESI Products"); or
- (5) any other products sold as authorized generic drugs in the U.S (hereinafter "Authorized Generics").

Dues are proportional to the size of the company and are based on the company's reported annual U.S. revenue with a minimum and maximum established by the AAM Board of Directors annually. Please email [AAM.membership](mailto:AAM.membership) for more details.

## AAM Step-up Regular Members

The qualifications are the same as an AAM regular member (see above). However, annual U.S. revenue must be less than \$250M. Entity must be a first-time AAM regular member. Membership term is limited to one year at a reduced rate. Please email [AAM membership](#) for more details.
